WHEREAS, presented for consideration and appropriate action is the proposed resolution of Honorable Jessie Niel C. Paulo to request the Municipal Mayor, Honorable Junaflor S. Cerilles to provide one (1) additional unit of mobile patrol vehicle to Municipal Police Station of Dumalinao for the use of mobilization, watch . and patrol within the locality;

WHEREAS, the maintenance of peace and order is of the highest and paramount priority which the mobility of personnel is essential to cover its area of responsibility and for its constant vigilance in the safety and security of property and people;

WHEREAS, for the effective and efficient watch and patrol in the area of responsibility, the same needs additional or supplementary service in the form of mobile patrol vehicles;
