WHEREAS, presented for consideration and appropriate action, is the proposed resolution of Hon. Rholly A. Labang to support the request of Barangay Local Government of Metokong to ask financial assistance to the Congresswoman of the 2nd District of Zamboanga del Sur, Honorable Jeyzel Victoria C. Yu for the installation of Solar Street Lights in Barangay Metokona, Municipality of Dumalinao, Zamboanga del Sur;
