**RESOLUTION DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF BARANGAY BIBILIK, DUMALINAO, ZAMBOANGA DEL SUR FOR FISCAL YEAR 2021 AMOUNTING TO TWO MILLION SIX HUNDRED FIFTY TWO THOUSAND FIVE HUNDRED FIVE PESOS (Php2, 652, 505.00)**

**WHEREAS**, presented to this august body for appropriate action, the Barangay Annual Budget of Bibilik, Dumalinao, Zamboanga del Sur for CY 2021 with approved Appropriation Ordinance No. 10-02 S'2020, subject to all accounting and auditing rules and procedures;

LIGAN** the body resolved, as it hereby resolves to declare valid and operative the Annual Budget for Fiscal Year 2021 of Barangay Bibilik, Dumalinao, Zamboanga del Sur in the amount of Two Million Six Hundred Fifty Two Thousand Five Hundred Five Pesos (Php2, 652, 505.00).
