**RESOLUTION DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF BARANGAY TUBO-PAIT, DUMALINAO, ZAMBOANGA DEL SUR FOR FISCAL YEAR 2021 AMOUNTING TO ONE MILLION EIGHT HUNDRED SEVENTY SIX THOUSAND SIX HUNDRED FIFTY SEVEN PESOS (Php1, 876, 657.00)**

**WHEREAS**, presented to this august body for appropriate action, the Barangay Annual Budget of Tubo-pait, Dumalinao, Zamboanga del Sur for CY 2021 with approved Appropriation Bill No. 01 S'2020, subject to all accounting and auditing rules and procedures;

LIGAN** the body resolved, as it hereby resolves to declare valid and operative the Annual Budget for Fiscal Year 2021 of Barangay Tubo-pait, Dumalinao, Zamboanga del Sur in the amount of One Million Eight Hundred Seventy Six Thousand Six Hundred Fifty Seven Pesos (Php1, 876, 657.00)


