RESOLUTION REQUESTING THE PHILIPPINE NATIONAL POLICE, MUNICIPAL POLICE STATION OF DUMALINAO, ZAMBOANGA DEL SUR, HEADED BY PMAJ JOEL M GALLERIANA, CHIEF OF POLICE OF DUMALINAO TO CONDUCT LAW ENFORCEMENT ACTIVITY/OPERATION IN THE REMOTE BARANGAYS IN THE LOCALITY IN CONNECTION TO THE COVID-19 PROTOCOLS AND THE MANDATORY AND APPROPRIATE WEARING OF FACE MASK AND OBSERVANCE OF PHYSICAL DISTANCING ORDINANCE OF 2020

WHEREAS, presented to this august body for appropriate action, is the request of LIGA ng mga Barangay of Dumalinao, Zamboanga del Sur represented by its ABC President Honorable Jessie Niel C. Paulo to request the Philippine National Police (PNP), Municipal Police Station of Dumalinao, Zamboanga del Sur, headed by PMAJ Joel M Galleriana, Chief of Police of Dumalinao, to conduct law enforcement activity/operation in the remote barangays in the locality in connection to the COVID-19 protocols and the Mandatory and Appropriate Wearing of Face Mask and Observance of Physical Distancing Ordinance of 2020;

WHEREAS, the LIGA ng mga Barangays passed a resolution endorsing to the Sangguniang Bayan of Dumalinao, Zamboanga del Sur to request the PNP-Dumalinao, headed by its Chief of Police PMAJ Joel M Galleriana, to conduct

law enforcement activity/operation in the remote barangays in the locality in connection to the COVID-19 protocols and the Mandatory and Appropriate Wearing of Face Mask and Observance of Physical Distancing Ordinance of 2020;

WHEREAS, the R.A 7160 otherwise known as the Local Government Code of the Philippines provides that local government units shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance which are essential to the promotion of the general welfare;

WHEREAS, the province of Zamboanga del Sur is under Modified Community Quarantine pursuant to Executive Order No. 2021-16 that was signed by the provincial governor;

WHEREAS, the Ordinance No. 2020-06-450 enacted by the Sangguniang Bayan of Dumalinao, specifically section 8 provides that the enforcement of Mandatory and Appropriate Wearing of Face Mask and Observance of Physical Distancing shall be tasked to the Philippine National Police, Municipal Police of Dumalinao, Zamboanga del Sur;


WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;


