**WHEREAS**, presented for consideration and appropriate action is the request of the Local Chief Executive to authorize her to enter into and sign a Memorandum of Agreement with the different stakeholders stated above for the implementation of Disaster Relief Operation Partnership during disaster occurrence within the locality;

**WHEREAS**, , Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

**WHEREAS**, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;

**WHEREAS**, the Local Government Unit of Dumalinao recognizes the importance of a coordinated and efficient relief operation partnership during times of disaster to ensure the safety and well-being of its constituents;

**WHEREAS**, the LGU-Dumalinao also aims to foster collaboration among government agencies, non-governmental organizations, private entities, and other relevant stakeholders to optimize resources and facilitate effective disaster management;

**WHEREAS**, it is necessary to establish formal agreements with various stakeholders to enhance disaster response and relief efforts within the locality;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. HERMES B. CABALES**, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junafior S.
