RESOLUTION ADOPTING THE APPROVED RESOLUTION OF MUNICIPAL DEVELOPMENT COUNCIL (MDC) REPROGRAMMING THE AMOUNT OF ONE MILLION FIVE HUNDRED NINETY THREE THOUSAND THREE HUNDRED FIFTY PESOS AND TWENTY THREE CENTAVOS (Php1, 593, 350.23) TAKEN FROM C.Y. 2020 OF THE 20% ECONOMIC DEVELOPMENT FUND OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.




