RESOLUTION NO. 0205-2023

AUTHORIZING THE LOCAL CHIEF EXECUTIVE/MDRRMC CHAIRPERSON, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, AND THE MUNICIPAL TREASURER, GUALBERTO U. GEMINA, JR., TO OPEN A SPECIAL TRUST ACCOUNT UNDER THE ACCOUNT NAME OF DUMALINAO DRRM-ALLIANCE AND SHALL BE AN AUTHORIZED SIGNATORIES TO ALL TRANSACTIONS OF THE DUMALINAO DISASTER RISK REDUCTION MANAGEMENT ALLIANCE AT LANDBANK OF THE PHILIPPINES (LBP), PAGADIAN CITY BRANCH.

WHEREAS, presented for consideration and appropriate action is the approved Resolution No. 02 Series of 2023 of the Municipal Disaster Risk Reduction Management Council (MDRRMC);

WHEREAS, Section 22 (c) of R.A 7160, otherwise known as the Local Government Code of 1991, provides, that every local government unit, as a corporation, shall, unless otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;



WHEREAS, the municipal mayor is empowered by the same Code to enter into contracts on behalf of the municipality, based on Section 444 (b) (1) (vi) thereof, which provides that upon authorization by the sangguniang bayan, represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, obligations, and such other documents made pursuant to law or ordinance;



WHEREAS, the Dumaliniao Disaster Risk Reduction Management Alliance was established in the Municipality of Dumaliniao, Province of Zamboanga del Sur, to promote and enhance community disaster risk reduction and management efforts, and it was composed of thirty barangays in the locality that agreed to contribute annually in the amount of Ten Thousand Pesos (10, 000.00) per barangay, while the MDRRMC will counterpart of Three Hundred Thousand Pesos (P300, 000.00) annually, which aimed at supporting disaster-related programs and projects;

WHEREAS, the DRRMA aims to coordinate and implement programs, projects, and activities geared towards mitigating the impact of the disaster, providing assistance to affected individuals and communities, and building resilience among residents;

WHEREAS, the successful execution of the DRRMA's initiatives requires adequate funding and financial management to ensure the effective utilization of available resources;

WHEREAS, it is crucial to establish a dedicated trust account exclusively for the DRRMA's funds to ensure transparency, accountability, and efficient financial management;

WHEREAS, these are the specimen signatures of Honorable Mayor Junaflor S. Cerilles and Municipal Treasurer Gualberto U. Gemina, Jr., for the abovementioned purpose:

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.



Resolution No. 02 Series of 2023

“A RESOLUTION REQUESTING THE SANGGUNIANG BAYAN OF DUMALINAO, ZAMBOANGA DEL SUR TO GRANT AUTHORITY TO OPEN A SPECIAL TRUST ACCOUNT FOR DUMALINAO DRRM ALLIANCE”

WHEREAS, the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of LGU Dumalinao, Zamboanga del Sur recognizes the importance of fostering alliances and partnerships with various organizations and stakeholders to strengthen disaster risk reduction and management efforts in our municipality;

WHEREAS, the collaboration was named the “Dumalinao Disaster Risk Reduction and Management Alliance (DDRRMA) composed of the thirty barangays of Dumalinao agreed to contribute annually in the amount of Ten Thousand Pesos (Php10,000.00) only per barangay while the MDRRMC will counterpart Three Hundred Thousand (Php300,000.00) annually which aimed at supporting disaster-related programs and initiatives;

WHEREAS, establishing a special trust account will facilitate transparent and accountable management of funds received and enhance the efficient utilization of resources;

WHEREAS, the Sangguniang Bayan has the authority to authorize the opening of special trust accounts for specific purposes as necessary and in compliance with existing laws and regulations;

WHEREAS, the proper financial management of funds received from alliances is essential in ensuring the effective implementation of disaster risk reduction and management projects;

WHEREFORE; on mass motion and severally seconded, it was;

RESOLVED AS IT IS HEREBY RESOLVED, that a resolution be made **REQUESTING THE SANGGUNIANG BAYAN OF DUMALINAO, ZAMBOANGA DEL SUR TO GRANT AUTHORITY TO OPEN A SPECIAL TRUST ACCOUNT FOR DUMALINAO DRRM ALLIANCE**.




