RESPECTFULLY REQUESTING ENGR. INOCENCIO P. SABUGAL, DISTRICT ENGINEER OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), 2ND DISTRICT OF ZAMBOANGA DEL SUR, TO RENDER AN OFFICIAL REPORT BEFORE THE LEGISLATIVE COUNCIL OF DUMALINAO RELATIVE TO THE STATUS OF ROAD PROJECT AT BARANGAY PAGLAUM, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution authored by Hon. Frederick R. Balandra, to request Engr. Inocencio P. Sabugal, District Engineer of the DPWH, 2nd District of Zamboanga del Sur, to render an official report before the Legislative Council of Dumalinao relative to the status of project at Barangay Paglaum, this municipality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, the construction and maintenance of efficient and safe road infrastructure are crucial for the overall development and well-being of a community;

WHEREAS, it has been observed that the subject road does not contain road shouldering and drainage which now becomes the concern of pedestrians and motorists;

WHEREAS, Engr. Inocencio P. Sabugal, the esteemed District Engineer of DPWH, 2nd District of Zamboanga del Sur, has been entrusted with the responsibility of overseeing road construction and maintenance in the aforementioned area;

WHEREAS, it is within the purview of the Legislative Council to ensure transparency, accountability, and efficient project management through regular updates and reporting from relevant government agencies;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves to respectfully requesting Engr. Inocencio P. Sabugal, District Engineer of the Department of Public Works and Highways (DPWH), 2nd District of Zamboanga del Sur, to convey an official report before the Legislative Council of Dumalinao relative to the status of road drainage and shouldering of road project at Barangay Paglaum, Dumalinao, Zamboanga del Sur.
