RESOLUTION RESPECTFULLY ENDORSING AND REQUESTING THE OFFICE OF HONORABLE MAYOR JUNAFLOR S. CERILLES TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF GROUT RIPRAP/WATER EROSION CONTROL IN THE AREA OF CHURCH IN DUMALINAO, BARANGAY REBOKON, DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, presented to this august body for appropriate action, is the letter request of the Church in Dumalinao through a resolution asking the Municipal Mayor Junafloor S. Cerilles to allocate funds for the construction of grout riprap/water erosion control in the area of Church in Dumalinao, Barangay Rebokon, Dumalinao, Zamboanga del Sur;

WHEREAS, there is a constant flooding during rainy season that caused enlarged erosion particularly in the Church in Dumalinao and other adjacent residential area thereof;

WHEREAS, in order to protect the safety and avoid accident it is necessary to construct a grout riprap/water erosion control in the said area;



WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;
