**RESOLUTION NO. 0222-2021**

**RESOLUTION DECLARING VALID AND OPERATIVE THE SANGGUNIANG KABATAAN ANNUAL BUDGET OF BARANGAY MOTOSAWA, DUMALINAO, ZAMBOANGA DEL SUR FOR FISCAL YEAR 2021 AMOUNTING TO THREE HUNDRED SEVENTY SIX THOUSAND FIVE HUNDRED NINETY FOUR PESOS AND SIXTY ONE CENTAVOS (Php376, 594.61)**

**WHEREAS**, presented to this august body for appropriate action, the Sangguniang Kabataan Annual Budget of Barangay Motosawa, Dumalinao, Zamboanga del Sur for CY 2021, involving an appropriation of Three Hundred Seventy Six Thousand Five Hundred Ninety Four Pesos and Sixty One Centavos (Php376, 594.61) with approved Resolution No. 01 S'2021;

**WHEREAS**, pursuant to Section 20 (a) of the SK Reform Act of 2015 Republic Act No.10742, ten percent (10%) of the general fund of the barangay shall be set aside for the SK. The Sangguniang barangay shall appropriate the SK funds in lump-sum, which shall be disbursed solely for youth development and empowerment purposes;

**WHEREAS**, Sangguniang Kabataan Annual Budget for CY 2021 of Barangay Motosawa was thoroughly reviewed by the Committee on Finance and Appropriation thru technical assistance of the Municipal Budget Office and found



to be in order and had complied with all the budgetary requirements of the Local Government Code of 1991 and its implementing rules and regulations and other laws, rules and regulations issued by the Department of Budget and Management;

**WHEREAS**, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ARNOLD L. FLORES** the body resolved, as it hereby resolves to declare valid and operative the Sangguniang Kabataan Annual Budget for Fiscal Year 2021 of Barangay Motosawa, Dumalinao, Zamboanga del Sur in the amount of Three Hundred Seventy Six Thousand Five Hundred Ninety Four Pesos and Sixty One Centavos (Php376, 594.61).
