### RESOLUTION NO. 0225-2021

**RESOLUTION GRANTING FINANCIAL ASSISTANCE TO MR. SERAFIN C. GOMEZ AND MRS. LIGAYA GOMEZ IN THE AMOUNT OF TWENTY ONE THOUSAND FIVE HUNDRED PESOS (Php21, 500.00) TO DEFRAY THE EXPENSES INCURRED OF THEIR SON'S DEATH WHO IS A REGISTERED MEMBER OF PERSONS WITH DISABILITY (PWD) IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR AND TO BE CHARGED AGAINST THE PERSONS WITH DISABILITY (PWD) BUDGET 2021.**

**WHEREAS**, presented to this august body for appropriate action, is the request of Mr. Serafin C. Gomez and Mrs. Ligaya Gomez, both resident of Barangay Piniglibano, this municipality, asking financial assistance to defray the burial of expenses of their son, Rich Anthon Gomez, who died due to Aspiration Pneumonia which was contributed by S/P Traumatic Brain Injury; Seizure Disorder last May 28, 2021;

**WHEREAS**, the Office of the Municipal Social Welfare and Development (MSWD)-Dumalinao, recommended through a Social Case Study Report dated last August 25, 2021 that Mr. and Mrs. Gomez is eligible for financial and/or burial assistance amounting to Twenty One Thousand Five Hundred Pesos (Php21, 500.00);



**WHEREAS**, spouses Gomez are indigent and in need of financial and/or burial assistance to defray the expenses of Rich Anthon's death which contributed to the socio-economic problem of the family;

**WHEREAS**, there is an available funds from the Persons with Disability (PWD) Budget 2021;

**WHEREAS**, after finding the same to be of great importance and help, this august body finds it necessary to grant financial assistance to spouses Gomez;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ARNOLD L. FLORES** the body resolved, as it hereby resolves to grant financial assistance to Mr. Serafin C. Gomez and Mrs. Ligaya Gomez in the amount of Twenty One Thousand Five Hundred Pesos (Php21, 500.00) to defray the expenses incurred of their son's death who is a registered member of persons with disability (PWD) in the Municipality Of Dumalinao, Zamboanga del Sur and to be charged against the Persons with Disability (PWD) budget 2021 .


