RESOLUTION APPROVING AND ADOPTING THE SUPPLEMENTAL NO. 1 OF ANNUAL INVESTMENT PROGRAM (AIP) 2021 OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.


