RESOLUTION UTILIZING THE AMOUNT OF ONE MILLION NINETY SEVEN THOUSAND THREE HUNDRED SIXTY EIGHT PESOS AND SEVENTY TWO CENTAVOS (Php1, 097, 368.72) FOR SALARY ADJUSTMENT 2021 TO ORGANIC PERSONNEL OF LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR, UNDER LOCAL BUDGET CIRCULAR 132.

WHEREAS, presented for consideration and appropriate action is the letter request of the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, to utilize the budget appropriated for salary adjustment amounting to One Million Ninety Seven Thousand Three Hundred Sixty Eight Pesos and Seventy Two Centavos (Php1, 097, 368.72) to organic personnel of Local Government Unit of Dumalinao, Zamboanga del Sur, under Local Budget Circular 132;

WHEREAS, under Local Budget Circular 132 provides the implementation of the Second Tranche of the Modified Salary Schedule for Local Government Personnel pursuant to Republic Act (RA) No. 11466;

WHEREAS, the Local Government Unit of Dumalinao has available funds for the implementation of Salary Adjustment under Appropriation Ordinance No. 2020-12-454 dated December 14, 2020, specifically the Personal Services with a lump sum amount of One Million One Hundred Eight Thousand Five Hundred Eighty Nine Pesos and Ninety Two Centavos (Php1, 108, 589.92);



WHEREAS, the funds for Salary Adjustment 2021 was taken from Personal Services of the different offices, to wit: Mayor's Office – Php12, 856.54, LDRRMO – Php61, 567.30, SB – Php253, 784.60, SB Secretary – Php53, 922.12, MPDC – Php5, 805.24, LCR – Php34, 810.05, MBO – Php58, 249.19, Accounting Office – Php80, 875.57, MTO – Php97, 532.07, Assessor's Office – Php65, 290.73, MSWDO – Php70, 780.83, RHU – Php44, 599.74, MEO – Php61, 872.35, MAO – Php60, 697.68, Market – Php77, 672.48, and DULWA – Php57, 052.24; ("**Annex A**")
