CERILLES, RMT, MAGD, TO ENTER INTO A MEMORANDUM OF AGREEMENT BY AND BETWEEN DEPARTMENT OF TRADE AND INDUSTRY (DTI) REPRESENTED BY ITS REGIONAL DIRECTOR ENGR. AL-ZAMIR I. LIPAE, CESO V, FOR THE IMPLEMENTATION OF LOCAL ECONOMIC ENTERPRISE OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, presented for consideration and appropriate action is the request of the Municipal Planning and Development Coordinator to authorize the Local Chief Executive to enter into a Memorandum of Agreement by and between Department of Trade and Industry (DTI) represented by its Regional Director, Engr. Al-zamir I. Lipae, CESO V, for the implementation of the following Local Economic Enterprise, to wit;

- 1. Coco Coir Processing; and**
- 2. Coffee and Cacao Processing.**

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.


