

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Jelito R. Peñonal to authorize the change of bank signatories under the LBP-Account name: "Sangguniang Bayan-Dumalinao, ZDS" and designating the Honorable Vice Mayor Wilfredo L. Malong, Sr., and the Municipal Treasurer Gualberto U. Gemina, Jr., to be an authorized signatories to all transactions of the Office of the Sangguniang Bayan of Dumalinao, Zamboanga del Sur at LBP-Pagadian Branch;

WHEREAS, Section 445 (a) (1), Article II of the Local Government Code of 1991, provides that the Municipal Vice-Mayors is empowered and authorized to sign all warrants drawn on the municipal for all expenditures appropriated for the operation of the sangguniang bayan;



WHEREAS, Pursuant to the Decision rendered by Regional Trial Court (RTC), Branch 19, Presiding Judge, Executive Judge Romeo T. Descallar, dated July 14, 2023 and the corresponding Writ of Execution issued by the Honorable Court dated October 3, 2023, the Honorable Vice Mayor Wilfredo L. Malong, Sr., is hereby declared as the duly elected Municipal Vice-Mayor of Dumalinao, Zamboanga del Sur, during the May 2022, National and Local Elections. As such, effective on October 3, 2023, Hon. Wilfredo L. Malong, Sr., is hereby and hereon performing the duties and functions of the Municipal Vice-Mayor of the Local Government Unit of Dumalinao, Zamboanga del Sur;
