RESPECTFULLY REQUESTING THE EXECUTIVE DIRECTOR DIONISIO G. ALVINDIA, PH.D OF THE PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION (PHILMECH) TO PROVIDE ONE (1) UNIT TRACTOR HARVESTER MACHINE AND MECHANICAL DRYER FOR THE FARMERS ORGANIZATION IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to respectfully request the Executive Director Dionisio G. Alvindia, Ph.D, of the PHILMECH to provide one (1) unit tractor harvester machine and mechanical dryer for the farmers organization in the locality;

WHEREAS, under Section 17 of Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates the Local Government Units to exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;
