RESOLUTION NO. 0261-2022

RESOLUTION GRANTING INCENTIVES TO ALL MOTORIZED VEHICLE FOR HIRE WHO ARE FULLY VACCINATED AND A MEMBER OF A REGISTERED/ACCREDITED TRANSPORT ASSOCIATION IN APPLYING OF OPERATORS PERMIT/FRANCHISE IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR

WHEREAS, presented to this august body for appropriate action, is the proposed grant of incentives to all motorized vehicle for hire who are fully vaccinated and a member of a registered/accredited transport association in applying of operators permit/franchise in the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, under Inter-Agency Task Force Resolution No. 148-B Series of 2021, the Local Government Units (LGUs) are strongly enjoined to issue orders or ordinances to ramp up demand for vaccination by, among others, providing incentives for fully vaccinated individuals, and for business establishments which institute measures that promote vaccination among their employees and clients, and to the extent allowed by law, requiring proof of vaccination before individuals and/or entities may undertake or qualify for certain activities;

WHEREAS, the Committee on Transportation proposed to provide a discount to vaccinated motorized vehicle owners as follows:

Sangguniang Bayan of Dumalinao, Zamboanga del Sur



- 1. 20% less/discount to partially vaccinated;
- 2. 30% less/discount to fully vaccinated; and
- 3. 40% less/discount to fully vaccinated plus booster shots.

WHEREAS, given the foregoing the body finds necessary to grant incentives to all motorized vehicle for hire as to protect and promote the right to health of the people in the locality;

WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by HON. GLEEWIN L. RUBIO the body resolved, as it hereby resolves to grant of incentives to all motorized vehicle for hire who are fully vaccinated and a member of a transport association in applying registered/accredited permit/franchise in the Municipality of Dumalinao, Zamboanga del Sur.
