**AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R. S. CERILLES, RMT, MAG, AND THE MUNICIPAL TREASURER GUALBERTO U. **WHEREAS**, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, the Local Government Unit of Dumalinao, Zamboanga del Sur, holds various accounts with the Land Bank of the Philippines, Pagadian City Branch, which have been dormant for a certain period;

**WHEREAS**, the reactivation of these accounts is deemed necessary to facilitate financial transactions and ensure the efficient utilization of funds for the benefit of the community;

**WHEREAS**, under existing banking rules and regulations, it is necessary that the Sangguniang Bayan authorize the Municipal Mayor and the Municipal Treasurer to reactivate said dormant accounts on behalf of the Local Government Unit of Dumalinao for any future bank transactions of the municipality;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ARNOLD L. FLORES**, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junafior S.
