RESOLUTION NO. 0264-2023

RESPECTFULLY REQUESTING THE CHIEF JUSTICE OF THE SUPREME COURT OF THE PHILIPPINES, HONORABLE ALEXANDER G. GESMUNDO, TO CAUSE THE IMMEDIATE IMPLEMENTATION OF THE PROPOSED CONSTRUCTION OF DUMALINAO, ZAMBOANGA DEL SUR HALL OF JUSTICE.

WHEREAS, presented for consideration and appropriate action is the request of the 8TH Municipal Circuit Trial Court (MCTC) Presiding Judge Pacifico T. Cimafranca, Jr., to respectfully request the Chief Justice of the Supreme Court of the Philippines, Hon. Alexander G. Gesmundo, to cause the immediate implementation of the proposed construction of Dumalinao, Zamboanga del Sur Hall of Justice;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, per A.M. No. 20-06-03-SC, Re: Proposed Construction of the Dumalinao, Zamboanga del Sur Hall of Justice Building, covered by purchase request No. 2020-17 dated February 13, 2020, has long been approved in the amount of P7, 500, 000.00, and such had long been referred to the PROCUREMENT PLANNING COMMITTEE for appropriate action. This fact is reflected in the *En Banc* NOTICE from the Supreme Court itself sent to all concerns by EDGAR O. ARICHETA (Copy attached as Annex A);

WHEREAS, Lot 10062-B-2, Psd-09-085282-D, with an area of 600 square meters, was donated by the four (4) Local Government Units, namely: Dumalinao, Tigbao, Guipos, and San Pablo, all province of Zamboanga del Sur, through their respective municipal mayors, duly authorized by the Sangguniang Bayan Resolutions to the Supreme Court of the Philippines and had been long transferred in the name of the latter on April 23, 2023 (Copy of TCT No. T-130-2023000962 as Annex B);

WHEREAS, the budget for this project has long been approved as of February 13, 2020, but its implementation has been drastically affected and delayed by the Covid-19 Pandemic;

WHEREAS, it is for the best interest and welfare of the four LGUs, its residents, court officials, personnel, litigants, and people who have transactions with the court that its Court House building be completed;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. HERMES B. CABALES**, the body resolved, as it hereby resolved to respectfully requesting the Chief Justice of the Supreme Court of the Philippines, Honorable Alexander G. Gesmundo, to cause the immediate implementation of the proposed construction of Dumalinao, Zamboanga del Sur Hall of Justice.


