**RESOLUTION NO. 0270-2022**

**RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD TO PURCHASE IN BEHALF OF THE LOCAL GOVERNMENT OF DUMALINAO, A PARCEL OF LAND OWNED AND REGISTERED BY MR. ROSARIO SUNOG WITH LOT NO. 7320-A, CONTAINING AN AREA OF 13, 075 SQUARE METERS LOCATED AT BARANGAY BANTA-AO, DUMALINAO, ZAMBOANGA DEL SUR, FOR THE LOCATION OF COFFEE AND COCOA FOOD PROCESSING AND FOR OTHER PUBLIC PURPOSES.**

**WHEREAS**, presented to this august body for appropriate action, is the request of the Municipal Assessor, to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to purchase in behalf of the Local Government of Dumalinao, a parcel of land amounting to owned and registered by Mr. Rosario Sunog with Lot No. 7320-A, containing an area of 13, 075 sq. meters located at Barangay Banta-ao, Dumalinao, Zamboanga del Sur,

**WHEREAS**, the Local Government Unit of Dumalinao allocated One Million Two Hundred Thousand Pesos (Php1, 200, 000.00) for the acquisition of the subject parcel of land;



**WHEREAS**, the registered owner of the said lot, located at Barangay Banta-ao is willing to sell his property to the Local Government Unit of Dumalinao;

**WHEREAS**, this august body finds the subject Deed of Sale is in order according to the provisions of Section 444, Paragraph (b) (1) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the Municipal Mayor to represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Bayan concerned pursuant to law or ordinance;


**WHEREAS**, after careful review and exhausted deliberation, finding the same sound, proper, and in order;






