RESOLUTION NO. 0271-2022

RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO S. CERILLES, RMT, MAGD TO SIGN AND EXECUTE IN BEHALF OF THE LOCAL GOVERNMENT OF DUMALINAO THE DEED OF SALE OF A PARCEL OF LAND, OWNED AND REGISTERED BY MR. ROSARIO SUNOG WITH LOT NO. 7320-A, CONTAINING AN AREA OF 13, 075 SQUARE METERS LOCATED AT BARANGAY BANTA-AO, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented to this august body for appropriate action, is the request of the Municipal Assessor, to authorize the Local Chief Executive, Honorable Mayor Junaflo S. Cerilles, RMT, MAGD, to sign and execute in behalf of the Local Government of Dumalinao the Deed of Sale of a parcel of land, owned and registered by Mr. Rosario Sunog with Lot No. 7320-A, containing an area of 13, 075 sq. meters located at Barangay Banta-ao, Dumalinao, Zamboanga del Sur;

WHEREAS, under Section 22 (c) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that no contract may be entered into by the Local Chief Executive, in behalf of the local government unit, without prior authorization by the Sanggunian concerned;



WHEREAS, the Deed of Sale was executed between the Local Government of Dumalinao and Mr. Rosario Sunog;

WHEREAS, this august body finds the subject Deed of Sale is in order according to the provisions of Section 444, Paragraph (b) (1) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the Municipal Mayor to represent the municipality in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Bayan concerned pursuant to law or ordinance;


WHEREAS, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ZENaida C. LOSABIA** the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, to sign and execute in behalf of the Local Government of Dumalinao the Deed of Sale of a parcel of land, owned and registered by Mr. Rosario Sunog with Lot No. 7320-A, containing an area of 13, 075 sq. meters located at Barangay Banta-ao, Dumalinao, Zamboanga del Sur.
