WHEREAS, presented for consideration and appropriate action is the resignation of Atty. Mayus Ryan D. Ando, dated November 20, 2023, in the position of Secretary of the Sanggunian in the Municipality of Dumalinao, Zamboanga del Sur, effective January 2, 2024;

WHEREAS, there is a need for an efficient and capable individual to assume the responsibilities of the position of Secretary to the Sanggunian temporarily, especially during the transition period and the vacancy of the position;
