III. PROJECT DETAILS

Rationale

In line with the desire of the Provincial Youth Development Program to Develop athletes at the grassroots level and to select the best talents to represent the Municipality of Dumalinao in the QUALCI-4 ATHLETIC ASSOCIATION MEET 2024, in partnership with the Department of Education (DEPED) Dumalinao District. This is also part of our continuing program geared towards youth development and our all-out war against illegal drugs.

Course Description

The activity involves 1-day Training in preparation for the 2-days Competition in the 2024 QULCI-4 ATHLETIC MEET to enhance the capability and skills of the athletes. This will be attended by 441 participants from the Municipality of Dumalinao.

The competition shall be conducted in the **Municipality of Lakewood, Zamboanga del Sur**. The District of Dumalinao (DepED) shall be the in-charge of the selection of athletes to participate in the said event. While the **LGU Dumalinao** shall be in-charge for the **foods, snacks, athletic uniforms & sports equipment** of the **441 participants** and the **transportation** of these Athletes from Dumalinao to Lakewood to their respective playing venues and vice-versa.

Project Objectives:

The activity primarily aimed to enhanced the capability and skills of the athletes to more competitive and develop the true spirit of sportsmanship.

Specifically at the end of the 1-day Training & 2-days Competition the Athletes are expected to:

- Gain in-depth knowledge and skills in their chosen sports event;
- Enhanced the basic skills, these Athletes may have;
- Improved Athletes performance to strive for excellence;
- Acquire understanding on their specific event and develop appreciation on effective management approaches;
- Build deeper appreciation of their roles and responsibilities as Municipal Athletes;
- Develop camaraderie, sportsmanship and competitiveness in their respective sports event.
