

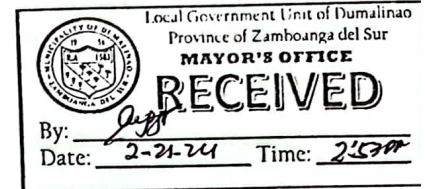

RESOLUTION NO. 0286-A-2024

DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF BARANGAY PAGLAUM, DUMALINAO, ZAMBOANGA DEL SUR FOR THE CALENDAR YEAR 2024, AMOUNTING TO FOUR MILLION TWO HUNDRED EIGHTY-FIVE THOUSAND SEVEN HUNDRED SEVENTY-FOUR PESOS (PHP4, 285, 774.00), SUBJECT TO ALL ACCOUNTING AND AUDITING RULES AND PROCEDURES.

WHEREAS, presented for consideration and appropriate action is the Annual Budget of Barangay Paglaum, Dumalinao, Zamboanga del Sur for Calendar Year 2024, amounting to Four Million Two Hundred Eighty-Five Thousand Seven Hundred Seventy-Four Pesos (Php4, 285, 774.00) with approved Barangay Appropriation Ordinance No. 1 dated September 18, 2023;

WHEREAS, programs, projects and activities reflected in the budget documents are in conformity with existing laws, rules, and regulations set forth on Book III, Chapter 4, Section 391 paragraph (a). Sub-paragraph (3) of the Local Government Code of 1991 which states that:

(3) Enact Annual and Supplemental Budget in accordance with the provision of this Code;

WHEREAS, Annual Budget for Calendar Year 2024 of Barangay Paglaum was thoroughly reviewed by the Committee on Budget, Finance, and Appropriation



thru technical assistance and recommendation of the Local Finance Committee and found to be in order and had complied with all the budgetary requirements of the Local Government Code of 1991;

WHEREAS, items appropriated under Barangay Appropriation Ordinance No. 1 of Barangay Paglaum is hereby considered operative in its entirety;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA** the body resolved, as it hereby resolves to declare valid and operative the Annual Budget of Barangay Paglaum, Dumalinao, Zamboanga del Sur for Calendar Year 2024, amounting to Four Million Two Hundred Eighty-Five Thousand Seven Hundred Seventy-Four Pesos (Php4, 285, 774.00), subject to all accounting and auditing rules and procedures.
