RESOLUTION NO. 0295-2024

RESPECTFULLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R. CERILLES, RMT, MAGD, THROUGH THE OFFICE OF THE MUNICIPAL ENGINEERING TO PROVIDE A PROGRAM OF WORKS (POW) AND DETAILED DESIGN OF THE PROPOSED CONSTRUCTION OF THE ETERNAL GARDEN PROJECT OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to respectfully request the Local Chief Executive through the Office of the Municipal Engineering to provide a Program of Works (POW) and detailed design of the proposed construction of the Eternal Garden Project of the municipality;

WHEREAS, Section 447, (a), (1), of Article III, Chapter III of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan, as the legislative body shall pass resolutions necessary for an efficient and effective municipal government pursuant to Section 16 of this Code;

WHEREAS, the August body recognizes the importance of establishing spaces for memorialization and reflection for its residents. The proposed construction of the Eternal Garden Project aligns with the municipality's commitment to providing essential services and facilities for its constituents;



WHEREAS, the construction of the Eternal Garden Project necessitates comprehensive planning and detailed design to ensure its functionality, services, and features;

WHEREAS, the Municipal Engineering Office is entrusted with the responsibility of developing, designing, and implementing infrastructure projects within the municipality;

WHEREAS, the provision of a Program of Works (POW) and Detailed Design for the proposed construction of the Eternal Garden Project is essential in guiding the project implementation process;

WHEREAS, due to the urgency of the project mentioned above, the Municipal Engineering Office is given a two (2) weeks period to provide the POW and Detailed Design to the Committee on Infrastructure and/or before the sangguniang bayan session;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves to respectfully request the Local Chief Executive, Honorable Mayor Junafior S. Cerilles, RMT, MAGD, through the Office of the Municipal Engineering to provide a Program of Works (POW) and detailed design of the proposed construction of the Eternal Garden Project of the Municipality of Dumalinao, Zamboanga del Sur.
