RESOLUTION RECOMMENDING TO THE LOCAL INTER-AGENCY TASK FORCE COUNCIL OF DUMALINAO, ZAMBOANGA DEL SUR, THE REQUEST OF TICKWAS ELEMENTARY SCHOOL, ALLOWING THEM TO PARTICIPATE IN THE PROGRESSIVE EXPANSION PHASE LIMITED FACE TO FACE CLASSES FOR THE SCHOOL YEAR 2021-2022.
