RESOLUTION NO. 0300-2024

RESPECTFULLY REQUESTING AND AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLO R. CERILLES, RMT, MAGD, TO UNDERTAKE THE NECESSARY STEPS AND PROCEDURES TO APPLY FOR A LAND SURVEY AT THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR-IX) OF THE PROPOSED AREA OF THE DUMALINAO ETERNAL GARDEN PROJECT COVERED BY LOT NO. 5780 CONTAINING AN AREA OF 11144.40 SQUARE METERS LOCATED AT BARANGAY ANONANG, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to respectfully request and authorize the Local Chief Executive to undertake the necessary steps and procedures to apply land survey at the DENR, Region IX of the proposed area of the Dumalinao Eternal Garden Project covered by Lot No. 5780 containing an area of 11144.40 square meters located at Barangay Anonang, Dumalinao, Zamboanga del Sur;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, the Municipality of Dumalinao has identified the need for the establishment of the Dumalinao Eternal Garden to address the growing demands for burial spaces and to provide a serene and well-maintained environment for the interment of the departed loved ones of our community;

WHEREAS, Lot No. 5780, comprising an area of 11,144.40 square meters situated at Barangay Anonang, Dumalinao, Zamboanga del Sur, has been identified as the proposed site for the said Dumalinao Eternal Garden Project;

WHEREAS, in accordance with pertinent laws and regulations, it is necessary to conduct a land survey of the proposed area to accurately delineate its boundaries and ensure its proper documentation and legal recognition;

WHEREAS, the Department of Environment and Natural Resources (DENR), Region IX, is the designated government agency tasked with overseeing land surveys and issuing the necessary certifications pertaining thereto;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA**, the body resolved, as it hereby resolves to respectfully request and authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD, to undertake the necessary steps and procedures to apply for a land survey at the Department of Environment and Natural Resources, Region IX, of the proposed area of the Dumalinao Eternal Garden Project covered by Lot No. 5780, containing an area of 11,144.40 square meters located at Barangay Anonang, Dumalinao, Zamboanga del Sur.
