RESOLUTION NO. 0311-2024

REMINDED THE DUMALINAO TRAFFIC UNIT TO APPREHEND AND CONFISCATE THE UNAUTHORIZED MUFFLER AND IMPROVISED MUFFLER SET UP ON A MOTORCYCLE BELOW 400 CUBIC CAPACITY (CC) WITHIN THE LOCALITY PURSUANT TO ARTICLE N, (A) OF THE MUNICIPAL ORDINANCE NO. 2020-03-441, OF THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Jelito R. Peñonal to remind the Dumalinao Traffic Unit to apprehend and confiscate the unauthorized and improvised muffler set up on a motorcycle below 400 CC within the locality pursuant to Article N, (A) of the Municipal Ordinance No. 2020-03-441, of the municipality;

WHEREAS, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;



WHEREAS, it has come to the attention of the Committee on Transportation and Communication that there is a prevalence of unauthorized and improvised muffler setups on motorcycles below 400 CC within the locality;

WHEREAS, under Article N, (A) of the Municipal Ordinance No. 2020-03-441, it is mandated that such unauthorized muffler setups are subject to apprehension and confiscation by the Dumalinao Traffic Unit;

WHEREAS, the unauthorized and improvised muffler setups on motorcycles have been observed to contribute to noise pollution and disturb the peace and tranquillity of the municipality;

WHEREAS, the enforcement of existing regulations is crucial in maintaining order and safety on our roads, as well as preserving the quality of life for our residents;


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. JELITO R. PEÑONAL**, the body resolved, as it hereby resolves to remind the Dumalinao Traffic Unit to apprehend and confiscate the unauthorized and improvised muffler set up on a motorcycle below 400 Cubic Capacity within the locality pursuant to Article N, (A) of the Municipal Ordinance No. 2020-03-441, of the Municipality of Dumalinao, Zamboanga del Sur.


