DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF BARANGAY ANONANG, DUMALINAO, ZAMBOANGA DEL SUR FOR THE CALENDAR YEAR 2024, AMOUNTING TO TWO MILLION EIGHT HUNDRED FIFTY SEVEN THOUSAND FOUR HUNDRED NINE PESOS (PHP2, 857, 409.00), SUBJECT TO ALL ACCOUNTING AND AUDITING RULES AND PROCEDURES.

WHEREAS, presented for consideration and appropriate action is the Annual Budget of Barangay Anonang, Dumalinao, Zamboanga del Sur for Calendar Year 2024, amounting to Two Million Eight Hundred Fifty Seven Thousand Four Hundred Nine Pesos (Php2, 857, 409.00) with approved Barangay Appropriation Bill No. 001;
