RESOLUTION NO. 0325-2024

DECLARING VALID AND OPERATIVE THE ANNUAL BUDGET OF CUATRO-CUATRO, DUMALINAO, ZAMBOANGA DEL SUR FOR THE CALENDAR YEAR 2024, AMOUNTING TO TWO MILLION THREE HUNDRED THOUSAND SIX HUNDRED EIGHTY-TWO PESOS (PHP2, 300, 682.00), SUBJECT TO ALL ACCOUNTING AND AUDITING RULES AND PROCEDURES.

WHEREAS, presented for consideration and appropriate action is the Annual Budget of Barangay Cuatro-Cuatro, Dumalinao, Zamboanga del Sur for Calendar Year 2024, amounting to Two Million Three Hundred Thousand Six Hundred Eighty-Two Pesos (Php2, 300, 682.00) with approved Barangay Appropriation Bill No. 2 Series of 2023;

WHEREAS, Section 447, (a), (1), (i), Article III, Title II of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan shall review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, programs, projects and activities reflected in the budget documents are in conformity with existing laws, rules, and regulations set forth on Book III,

Chapter 4, Section 391 paragraph (a). Sub-paragraph (3) of the Local Government Code of 1991 which states that:

(3) Enact Annual and Supplemental Budget in accordance with the provision of this Code;

WHEREAS, Annual Budget for Calendar Year 2024 of Barangay Cuatro-Cuatro was thoroughly reviewed by the Committee on Budget, Finance, and Appropriation thru technical assistance and recommendation of the Local Finance Committee and found to be in order and had complied with all the budgetary requirements of the Local Government Code of 1991;

WHEREAS, items appropriated under Barangay Appropriation Bill No. 2 Series of 2023 of Barangay Cuatro-Cuatro is hereby considered operative in its entirety;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ARNOLD L. FLORES**, the body resolved, as it hereby resolves to declare valid and operative the Annual Budget of Barangay Cuatro-Cuatro, Dumalinao, Zamboanga del Sur for the Calendar Year 2024, amounting to Two Million Three Hundred Thousand Six Hundred Eighty-Two Pesos (Php2, 300, 682.00), subject to all accounting and auditing rules and procedures.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
