**RESOLUTION NO. 0326-2022**

**RESOLUTION REMINDING ALL BARANGAY OFFICIALS AND/OR COUNCIL IN THE MUNICIPALITY OF DUMALINAO TO CREATE A POSITION FOR BARANGAY INDIGENOUS PEOPLE MANDATORY REPRESENTATIVE IN THE STAFFING PATTERN TO THEIR RESPECTIVE BARANGAY ANNUAL BUDGET 2023 AND PROVIDE FUNDS FOR THE PURPOSE THEREOF.**

**WHEREAS**, presented for consideration and appropriate action is the request of the Indigenous People Mandatory Representative (IPMR) to remind all barangay officials and/or council in the Municipality of Dumalinao to create a position for Barangay Indigenous People Mandatory Representative in the Staffing Pattern to their respective Barangay Annual Budget 2023 and provide funds for the purpose thereof;

**WHEREAS**, Section 16, R.A 8371, specifically provides that, IPs shall have the right to participate fully, if they so choose, at all levels of decision-making in matters which may affect their rights, lives and destinies through procedures determined



by them as well as to maintain and develop their own indigenous political structures. Consequently, the State shall ensure that the ICCs/IPs shall be given mandatory representation in policy-making bodies and other local legislative councils;

**WHEREAS**, Section 11, NCIP Administrative Order No. 03, S. 2018, provides that the selection process shall be in accordance with their local guidelines that is consistent with their customary laws. Upon receipt of the verified validation report and copy of the local guidelines, the RD, or the Provincial Officer (POer) as the case may be, shall issue the COA. Thereafter, the chosen IPMR shall take the appropriate oath before an authorized officer. The NCIP shall then notify the appropriate bodies for his/her assumption to office;

**WHEREAS**, Section 12, in the same Administrative Order, states that, the term of office of the IPMR in the local legislative councils shall be for a period of three (3) years and shall commence from the time of actual assumption to office and can re-indorsed for another term by the ICCs/IPs constituents, but in no case shall the representative serve for more than two (2) consecutive terms, except in LGUs where a term rotation agreement has been reached by several IP groups limiting the holding of office to one terms for every community;

**WHEREAS**, pursuant to the abovementioned Administrative Order provides that the compensation, benefits, and other emoluments of the IPMR shall be the same with that of the regular members of the concerned legislative bodies as prescribed in R.A 7160 and other applicable laws;

**WHEREAS**, out of thirty (30) barangays in the locality, there are seven (7) barangays that have already selected their respective barangay IPMR in accordance with the rules and procedure of the selection with the corresponding Certificate of Affirmation (COA) issued by NCIP-Pagadian;

**WHEREAS**, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ROMEO D. PARILA** the body resolved, as it hereby resolves to remind all barangay officials and/or council in the Municipality of Dumalinao to create a position for Barangay Indigenous People Mandatory Representative in the Staffing Pattern to their respective Barangay Annual Budget 2023 and provide funds for the purpose thereof.

**LET** the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
