RESOLUTION NO. 0328-2022

RESOLUTION RECOMMENDING TO THE LOCAL INTER-AGENCY TASK FORCE COUNCIL OF DUMALINAO, ZAMBOANGA DEL SUR, THE REQUEST OF REBOKON AGRICULTURAL AND VOCATIONAL HIGH SCHOOL, ALLOWING THEM TO PARTICIPATE IN THE PROGRESSIVE EXPANSION PHASE LIMITED FACE TO FACE CLASSES FOR THE SCHOOL YEAR 2021-2022.

WHEREAS, presented to this august body for appropriate action, the request of Rebokon Agricultural and Vocational High School represented by its school head Mr. Wilson R. Panuncillon, to allow them to participate in the Progressive Expansion Phase Limited Face to Face Classes for the School Year 2021-2022;
