RESOLUTION RECOMMENDING TO THE LOCAL INTER-AGENCY TASK FORCE COUNCIL OF DUMALINAO, ZAMBOANGA DEL SUR, THE REQUEST OF DUMALINAO REGIONAL PILOT SCHOOL-SPED, ALLOWING THEM TO PARTICIPATE IN THE PROGRESSIVE EXPANSION PHASE LIMITED FACE TO FACE CLASSES FOR THE SCHOOL YEAR 2021-2022.

WHEREAS, presented to this august body for appropriate action, the request of Dumalinao Regional Pilot School-SPED, represented by its school head Ms. Ernilyn E. Ligan, to allow them to participate in the Progressive Expansion Phase Limited Face to Face Classes for the School Year 2021-2022;




