**RESOLUTION NO. 0343-2022**

**AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENTER INTO A CONTRACT OF AGREEMENT BY AND BETWEEN THE HEIRS OF SEGUNDA NACILLA REPRESENTED BY DANILO U. NACILLA FOR THE LEASE OF LAND WHERE THE SOURCE OF THE POTABLE WATER ON WHICH AN INTAKE BOX OWNED BY THE LOCAL GOVERNMENT UNIT OF DUMALINAO WAS CONTRUCTED/INSTALLED LOCATED AT BARANGAY TINA, DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented to this august body for appropriate action is the manifestation by Hon. Zenaida C. Losabia to authorize the Local Chief Executive to enter into a Contract of Agreement by and between the Heirs of Segunda Nacilla represented by Danilo U. Nacilla for the lease of the land where the source of the potable water on which an intake box owned by the LGU-Dumaliniao was constructed/installed located at Barangay Tina, Dumaliniao, Zamboanga del Sur;

**WHEREAS**, the Heirs of SEGUNDA NACILLA are the absolute owners of a parcel of land covered by Tax Declaration No. 16-05-0028-00093 located at Barangay Tina, Dumaliniao, Zamboanga del Sur and which is more particularly described as follows:

*"A parcel of land bounded on NE., by Lot No. 5722: on the East by Lot No. 5717 and 6508 on the South by Lot No. 6511 and 5718 and on the West by Lot No. 5819*



and 5721, containing an area of NINETY TWO THOUSAND EIGHT HUNDRED SIXTY ONE (92, 861) SQUARE METERS, located at Barangay Tina, Dumalinao, Zamboanga del Sur and covered by Arp No. 16-05-0028-00093 declared under the name of the late SEGUNDA NACILLA;"

**WHEREAS**, a portion of the above-described parcel of land is a source of potable water on which an intake box has been construct/installed by the Local Government Unit of Dumalinao, Zamboanga del Sur;

**WHEREAS**, the said source was currently use to supply water to residential, industrial and commercial in the locality;


**WHEREAS**, after careful review and exhausted deliberation, finding the same sound, proper, and in order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ZENaida C. LOSABIA** the body resolved, as it hereby resolves to authorize the Local Chief Executive to enter into a Contract of Agreement by and between the Heirs of Segunda Nacilla represented by Danilo U. Nacilla for the lease of the land where the source of the potable water on which an intake box owned by the LGU-Dumalinao was constructed/installed located at Barangay Tina, Dumalinao, Zamboanga del Sur.


