**RESOLUTION NO. 0344-2022**

**AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO CONDUCT CLEARING OPERATION STARTING FROM THE FRONT AREA OF QUIBOY TO TAN SEE KEE, AND DOWN TO ROMAN LOCATED AT PUROK MALINAWON B BARANGAY PAGLAUM PURPOSELY TO BE USED AS SITE FOR THE CONSTRUCTION OF LOCAL TRANSPORT TERMINAL IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented to this august body for appropriate action is the manifestation by Hon. Jelito R. Peñonal, Committee Chairman on Transportation to authorize the Local Chief Executive to conduct clearing operation starting from the front area of Quiboy to Tan See Kee, and down to Roman located at Purok Malinawon B, Barangay Paglaum purposely to be used as site for the construction of Local Transport Terminal in the Municipality of Dumalinao, Zamboanga del Sur;

**WHEREAS**, under Section 17, R.A 7160, otherwise known as the Local Government Code of 1991, mandates local government units to exercise powers and discharge functions and responsibilities as are necessary, appropriate, or incidental to the efficient and effective provision of infrastructure facilities including local roads and bridges;



**WHEREAS**, the front area of Quiboy, Tan See Kee and Roman at Barangay Paglaum has been publicly known as site which was previously utilized by the Local Government Unit of Dumalinao, Zamboanga del Sur. The same place has been used since time immemorial;

**WHEREAS**, the LGU-Dumalinao wanted to build a unified and permanent Integrated Bus Terminal in the locality in order to provide a place to all public utility vehicles, conducive and safe to the riding public;

**WHEREAS**, after careful review and exhausted deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. ZENAIDA C. LOSABIA** the body resolved, as it hereby resolves to authorize the Local Chief Executive to conduct clearing operation starting from the front area of Quiboy to Tan See Kee, and down to Roman located at Purok Malinawon B, Barangay Paglaum purposely to be used as site for the construction of Local Transport Terminal in the Municipality of Dumalinao, Zamboanga del Sur.
