RESOLUTION NO. 0358-2024

APPROVING THE ESTABLISHMENT OF BIRTHING FACILITY AT RURAL HEALTH UNIT OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Municipal Health Officer to approve the establishment of Birthing Facility at RHU Dumalinao, Zamboanga del Sur;

WHEREAS, Section 17 (b) (2) (iii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides, among others, that the Municipal Government shall exercise its power and discharge such functions and responsibilities as are necessary for efficient and effective provision of basic health services that deliver programs and projects on maternal and child care and purchase of medicines, supplies, and equipment;

WHEREAS, the Local Government Unit of Dumalinao recognizes the importance of accessible maternal and child health services in promoting the well-being of its residents;

WHEREAS, the establishment of a birthing facility within the Rural Health Unit of Dumalinao will significantly improve the healthcare services available to pregnant women and newborns in the municipality and nearby areas;



WHEREAS, the provision of a birthing facility is aligned with the national government's goal of reducing maternal and infant mortality rates, and ensuring safe and healthy deliveries;

WHEREAS, the Rural Health Unit of Dumalinao has the capacity and readiness to operate a birthing facility, given its existing infrastructure and personnel;

WHEREAS, community consultations and needs assessments have indicated strong support for the establishment of a birthing facility to address the healthcare needs of pregnant women and their families in the municipality


WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;
