**RESOLUTION NO. 0362-2024**

**EXPLICITLY PROHIBITING AND CONDEMNING THE ESTABLISHMENT OF MORO NATIONAL LIBERATION FRONT (MNLF) COMMUNITIES/CAMPS AND RECRUITMENT OF MEMBERS AT PUROK TALABA, BARANGAY CAMANGA, AND TO ALL BARANGAYS IN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.**

**WHEREAS**, presented for consideration and appropriate action is the proposed resolution of Hon. Jelito R. Peñonal to explicitly prohibits and condemn the establishment of MNLF Communities/Camps and recruitment of members at Purok Talaba, Barangay Camanga, and to all barangays in the locality;

**WHEREAS**, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise power expressly granted those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, the Department of the Interior and Local Government, Region IX endorsed to the Municipal Mayor Junafior S. Cerilles regarding the establishment of MNLF Community at Purok Talaba, Barangay Camanga, this municipality



through its letter dated July 8, 2024, and signed by the Regional Director, Paisal O. Abutazil;

**WHEREAS**, under the 1996 GRP-MNLF Final Peace Agreement, the MNLF does not authorize the establishment of new camps and recruitment of new members, and at the same time to establish MNLF camps or communities outside the jurisdiction of Bangsamoro Autonomous Region;

**WHEREAS**, as per reported by the Committee on Peace and Order and Public Safety, there are recruitment activities at Barangay Camanga using the name of MNLF to extort money from the people as "recruitment fees" in exchange and promise "ranks" or positions of "power" within the organization or access to any programs of the government;

**WHEREAS**, the establishment of MNLF Community and recruitment activities at Barangay Camanga violated the 1996 GRP-MNLF Final Peace Agreement, the existing national law, and since the Municipality of Dumalinao, Zamboanga del Sur is not part of the Bangsamoro Autonomous Region;

**WHEREAS**, it is in the best interest of the Municipality of Dumalinao to ensure that all its barangays remain free from any activities that could disrupt the harmony and safety of its residents;


**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**NOW, THEREFORE**, premises above-considered, on motion by **HON. JELITO R. PEÑONAL**, the body resolved, as it hereby resolves to explicitly prohibits and condemn the establishment of Moro National Liberation Front (MNLF) Communities/Camps and recruitment of members at Purok Talaba, Barangay Camanga, and to all barangays in the Municipality of Dumalinao, Zamboanga del Sur.

**LET** the copy of this resolution be furnished to concern offices and/or officials for reference, guidance and appropriate action.
