**RESOLUTION NO. 0365-2024**

**DECLARING VALID THE BARANGAY ORDINANCE NO. 06 SERIES OF 2024 OF SUMADAT, DUMALINAO, ZAMBOANGA DEL SUR, ENTITLED “AN ORDINANCE REQUIRING ALL HOUSEHOLDS OF BARANGAY SUMADAT, DUMALINAO, ZAMBOANGA DEL SUR TO PLANT VEGETABLES TO THEIR BACKYARD TO EMPOWER HEALTH SUSTAINABILITY IN THE COMMUNITY”.**

**WHEREAS**, presented for consideration and appropriate action is the Barangay Ordinance No. 06 Series of 2024 of Sumadat, Dumalinao, Zamboanga del Sur for review, which was referred to the SB Committee on Health and Sanitation for further study;

**WHEREAS**, Section 447, (a), (1), (i) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sanggunian bayan, as the legislative body of the municipality shall review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

**WHEREAS**, the aforesaid ordinance was then reported back to the August Body with the following findings and recommendation:



"Section 389, (b), (9) of Republic Act No. 7160, otherwise known known as the Local Government Code of 1991, states that for efficient, effective, and economical governance, the purpose of which is the general welfare of the barangay and its inhabitants pursuant to Section 16 of this Code, the punong barangay shall promote the general welfare of the barangay"; The Ordinance is in line with the municipal's advocacy "Go DREAM Dumalinao" which promotes a Green and Organic environment for the present and future generation;"

**WHEREAS**, the Committee recommended to declare the subject ordinance valid;


**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

**BARANGAY ORDINANCE NO. 66 Series of 2024**

**AN ORDINANCE REQUIRING ALL HOUSEHOLDS OF BARANGAY SUMADAT, DUMALINAO ZAMBOANGA DEL SUR TO PLANT VEGETABLES TO THEIR BACKYARD TO EMPOWER HEALTH SUSTAINABILITY IN THE COMMUNITY.**

**AUTHORIZED BY KAGAWAD EMMA B. SACAPAÑO**

**WHEREAS;** SECTION 15 of the 1987 PHILIPPINES CONSTITUTION declared that the state shall protect and promote the right to health of the people and instill health Conciousness among them;

**WHEREAS;** this policy of the state adheres to the general mission of the government to protect the life of its citizenry by establishing healthy activities like backyard gardening and to promote individual's awareness to environment protection by planting vegetable beneficial to man physical, social, economic and medical well- being;



EXERPTS FROM THE MINUTES 1<sup>ST</sup> REGULAR SESSION

WHEREAS; the barangay as the ultimate bridge of the state to the people and guided by its role and commitment to serve efficiently in bringing out sustainable living in the community has adopted backyard gardening to promote individual's health requiring every household to plant and grow vegetable in their backyard.

WHEREAS; the barangay administration, aware of the burgeoning prices of all basic commodities including vegetable has come to this end requiring all household of barangay Sumadat, Dumalinao Zamboanga del Sur to Plant and grow vegetable in their backyard to achieve health sustainability in the barangay level.

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED by the Sanggunian Barangay of Sumadat, Dumalinao Zamboanga del Sur in its regular session duly assembled;

Section 1. TITLE

THIS ORDINANCE SHALL BE KNOWN AS the MAINTENANCE AND SUSTAINABILITY OF THE BARANGAY BACKYARD VEGETABLE GARDEN.

Section 2. RECOMMENDATION SET - UP

- A. There shall be established in the barangay the SUMADAT VEGETABLE COMMITTEE to monitor that all household have planted vegetable to their backyard.
- B. The Punong Barangay shall assign the focal person to head this committee to ensure that this ordinance is properly implemented and followed accordingly.

Section 3. COMPOSITION AND FUNCTIONS

THE SUMADAT VEGETABLE GARDEN COMMITTEE shall be composed of the following.

1. Committee Chairman on Health - Heads the implementation of this ordinance
2. BHW AND BNS - each sectoral area - Monitors the implementation of the ordinance from their respective area in the barangay, collect and gather data.

3. BARANGAY SECRETARY - For reference and appropriate recommendations of concerned offices and officials

**Section 4. APPROPRIATION**

The Sanggunian Barangay of Sumadat, Dumalinao Zamboanga del Sur has appropriated the amount of Ten Thousand Pesos (₱10,000.) to purchase vegetable seeds in any variety.

**Section 5. SEPARABLE CLAUSE**

If for whatever reason, any provision of the ordinance is declared to be unconstitutional or invalid, the other provision hereof not so affected shall continue in full Force and effect.

**Section 6. REPEALING CLAUSE**


This ordinance shall take effect within Fifteen (15) days after its approval and the posting of the Full text of this Ordinance in two (2) conspicuous places of the barangay.




