RESPECTFULLY REQUESTING THE OFFICE IN-CHARGE DISTRICT ENGINEER, ENGR. MIGUEL C. BAYA OF DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), 2ND ENGINEERING DISTRICT OF THE PROVINCE OF ZAMBOANGA DEL SUR TO PLACE BACK THE ROAD BARRIERS AND TO DRAW ROAD LINES ALONG THE NATIONAL HIGHWAY OF BARANGAY SUMADAT AND LOCUBAN IN ENSURING SAFE AND EFFICIENT TRANSPORTATION WITHIN THE MUNICIPALITY OF DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Arnold L. Flores to respectfully requesting the OIC-District Engineer, Engr. Miguel C. Baya of Department of Public Works and Highways (DPWH), 2nd Engineering District of the Province of Zamboanga del Sur to place back the road barriers and to draw road lines along the national highway of Barangay Sumadat and Locuban in ensuring safe and efficient transportation within the locality;

WHEREAS, Section 447 (a), (5), (v) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the sangguniang bayan as the legislative body of the municipality, shall approve resolution to regulate the putting up of

signs, signpost, awnings and awning post on the street for the efficient and effective delivery of the basic facilities;

WHEREAS, the National Highway passing through Barangays Sumadat and Locuban is a vital transportation route for the residents and commuters within the Municipality of Dumalinao, Zamboanga del Sur;

WHEREAS, the absence of road barriers and road lines along the mentioned stretch of the highway has resulted in increased risk of accidents and has negatively impacted the safety and efficiency of transportation in the area;

WHEREAS, the reinstallation of road barriers and the drawing of proper road lines are essential measures to ensure the safety of motorists and pedestrians, prevent accidents, and improve the overall flow of traffic along the said highway;

WHEREAS, it is the responsibility of the Department of Public Works and Highways (DPWH) to maintain national roads and ensure that they are safe and accessible to all road users;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ARNOLD L. FLORES**, the body resolved, as it hereby resolves to respectfully request the OIC-District Engineer, Engr. Miguel C. Baya of Department of Public Works and Highways (DPWH), 2nd Engineering District of the Province of Zamboanga del Sur to place back the road barriers and to draw road lines along the national highway of Barangay Sumadat and Locuban in ensuring safe and efficient transportation within the Municipality of Dumalinao, Zamboanga del Sur.
