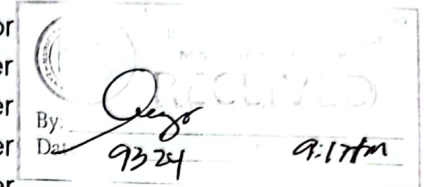

**RESOLUTION NO. 0378-2024**

**FAVORABLY REQUESTING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLORES S. CERILLES, RMT, MAGD, TO PULL OUT AND PROVIDE PARKING SPACE FOR ALL HEAVY EQUIPMENT OWNED BY THE LOCAL GOVERNMENT UNIT OF DUMALINAO, ZAMBOANGA DEL SUR FOR SAFEKEEPING PURPOSES.**

**WHEREAS**, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to favorably request the Local Chief Executive to pull out and provide parking space for all heavy equipment owned by the LGU-Dumalinao for safekeeping purposes;

**WHEREAS**, Section 447, (a), (1) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions necessary for an efficient and effective municipal government;

**WHEREAS**, the LGU-Dumalinao owns various heavy equipment utilized for public works, infrastructure development, disaster response, and other essential government services;

**WHEREAS**, it comes to this August Body that some of our heavy equipment has been parked and placed along the national highway, public places, and



residential areas, which can cause accidents and damage to other transient vehicles and property;

**WHEREAS**, it is of utmost importance that these heavy equipment assets are kept in good condition to prevent damage, wear and tear, and possible theft or misuse;

**WHEREAS**, there is a need to provide a secure and proper parking space for these heavy equipment units to ensure their safekeeping and maintain their operational readiness;

**WHEREAS**, designated parking space will allow for better monitoring, maintenance, and management of these assets, thereby prolonging their useful life and ensuring their availability for urgent use;


**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;
