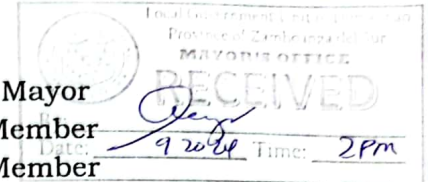

**RESPECTFULLY REQUESTING DIR. MARLON A. ALABATA, CPA, PROVINCIAL DIRECTOR OF THE DEPARTMENT OF TRADE AND INDUSTRY (DTI), ZAMBOANGA DEL SUR, TO CONDUCT SWEET POTATO CHIPS SKILLS TRAINING AND/OR HERBAL COFFEE MAKING TO INDIGENOUS PEOPLES OF BARANGAY CAMALIG, MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR AS PART OF THE CELEBRATION OF INDIGENOUS PEOPLES DAY ON OCTOBER 17, 2024.**

**WHEREAS,** presented for consideration and appropriate action is the proposed resolution of Hon. Romeo D. Parila to respectfully request the Provincial Director of DTI-Zamboanga del Sur, to conduct Sweet Potato Chips Skills Training and/or Herbal Coffee Making to IP of Barangay Camalig as part of the celebration of Indigenous Peoples Day on October 17, 2024;

**WHEREAS,** it is a Constitutional mandate of the State to recognize and promote the rights of indigenous cultural communities within the framework of national unity and development;

**WHEREAS,** Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;



**WHEREAS**, the LGU-Dumalinao, acknowledges the significant role of Indigenous Peoples in the local community and is committed to promoting their economic empowerment and cultural preservation;

**WHEREAS**, the Department of Trade and Industry (DTI) plays a vital role in fostering entrepreneurship, providing livelihood training, and supporting local industries, particularly for marginalized communities;

**WHEREAS**, the conduct of sweet potato chips skills training and/or herbal coffee making for Indigenous Peoples in Barangay Camalig will promote sustainable livelihood, encourage local entrepreneurship, and enhance economic development in the area;

**WHEREAS**, the said training programs shall be the opening part of the celebration of Indigenous Peoples Day and at the same time as the local government's efforts to support and uplift the Indigenous community;

**WHEREAS**, after careful review and exhaustive deliberation, and after finding the same to be proper and order;
