RESOLUTION NO. 0384-2024

APPROVING THE AUGMENTATION OF FUNDS FROM THE SAME EXPENSE CLASS OF MAINTENANCE AND OTHER OPERATING EXPENSES (MOOE) OF THE UNUTILIZED FUNDS OF REPAIRS AND MAINTENANCE OFFICE EQUIPMENT AMOUNTING TO FIFTY THOUSAND PESOS (PHP50, 000.00) TO PROCURE SUPPLIES AND MATERIALS IN THE OFFICE OF THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) OF THE MUNICIPALITY OF DUMALINAO, PROVINCE ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the request of the Municipal Local Government Operation Officer to approve the augmentation of funds from the same expense class of MOOE of the unutilized funds of Repairs and Maintenance Office Equipment amounting to Php50, 000.00 to procure supplies and materials in the Office of the DILG of the municipality;

WHEREAS, Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;

WHEREAS, Section VII of the Appropriation Ordinance No. 2023-12-497 provides that the Municipal Mayor and the Municipal Vice Mayor are hereby authorized to augment any item of appropriation in this budget for their respective executive and legislative officers by the way of Executive Order and



Resolution respectively, from appropriation savings, within the same expense class of the office

WHEREAS, the available MOOE funds of the DILG Office under Repairs and Maintenance Office Equipment that shall be used to augment funds under MOOE in the same office to procure supplies and materials amounting to Fifty Thousand Pesos (Php50, 000.00), to wit:

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

CABALES**, the body resolved, as it hereby resolves to approve the augmentation of funds from the same expense class of Maintenance and Other Operating Expenses (MOOE) of the unutilized funds of Repairs and Maintenance Office Equipment amounting to Fifty Thousand Pesos (Php50, 000.00) to procure supplies and materials in the Office of the Department Interior and Local Government of the Municipality of Dumalinao, Zamboanga del Sur.

LET the copy of this resolution be furnished to concern offices and/or officials for reference, guidance, and appropriate action.


