RESOLUTION NO. 0387-2024

RESPECTFULLY REQUESTING THE REGIONAL EXECUTIVE DIRECTOR, ARTURO E. FADRIQUELA, OF THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), REGION IX, THROUGH THE LAND MANAGEMENT BUREAU, TO PROVIDE RECORDS OF THE TOTAL LAND AREA WITH RESPECTIVE BARANGAY BOUNDARIES OF THE MUNICIPALITY OF DUMALINAO, PROVINCE OF ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Frederick R. Balandra to request the DENR-IX, through the Land Management Bureau, to provide records of the total land area with respective barangay boundaries of the locality;

WHEREAS, Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;

WHEREAS, the Office of the Sangguniang Bayan of Dumalinao receives compliant relative to boundary disputes between barangays within the municipality;

WHEREAS, boundary disputes between barangays can create confusion in governance, property rights, and public services, necessitating a fair and transparent resolution process;



WHEREAS, accurate and updated records of barangay boundaries and land areas are essential in resolving these disputes to ensure that decisions are based on reliable and objective data:

WHEREAS, the Department of Environment and Natural Resources (DENR), through its Land Management Bureau (LMB), is the agency responsible for land surveys, mapping, and management of land records, and therefore is in the best position to provide the needed information on the total land area and respective barangay boundaries of the Municipality of Dumalinao;

WHEREAS, such information is vital to assist the Municipal Government of Dumalinao, Province of Zamboanga del Sur, in resolving boundary disputes between its barangays to foster harmony, cooperation, and equitable distribution of resources in the locality;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by HON. FREDERICK R. BALANDRA, the body resolved, as it hereby resolves to respectfully request the Regional Executive Director, Arturo E. Fadriquela, of the Department of Environment and Natural Resources (DENR), Region IX, through the Land Management Bureau, to provide records of the total land area with respective barangay boundaries of the Municipality of Dumalinao, Province of Zamboanga del Sur.
