RESOLUTION NO. 0389-2024

AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE MAYOR JUNAFLOR S. CERILLES, RMT, MAGD, TO REGISTER AND ENROLL ALL ACCOUNTS OF THE LOCAL GOVERNMENT UNIT OF DUMALINAO MAINTAINED AT THE LAND BANK OF THE PHILIPPINES, PAGADIAN CITY BRANCH TO WE ACCESS SYSTEM, INCLUDING THE AUTHORIZERS AND MAKERS THEREOF.

WHEREAS, presented for consideration and appropriate action is the request of the Municipal Accountant to authorize the Local Chief Executive to register and enroll all accounts of the LGU-Dumalinao maintained at the LBP-Pagadian City Branch to WE ACCESS SYSTEM, including the authorizers and makers thereof;

WHEREAS, Section 447, (a), (5) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the sangguniang bayan as the legislative body of the municipality, shall pass resolutions to ensure the efficient and effective delivery of the basic services and facilities as provided under Section 17 of this Code;

WHEREAS, the Local Government Unit (LGU) of Dumalinao maintains various accounts with the Land Bank of the Philippines, Pagadian City Branch, for its financial transactions

WHEREAS, the WEACCESS SYSTEM, offered by the Land Bank of the Philippines, is an online banking facility that allows institutions to conduct



secure and efficient electronic transactions, including fund transfers, account inquiries, and payment processing;

WHEREAS, it is deemed necessary for the LGU of Dumalinao to utilize the WEACCESS SYSTEM to enhance the efficiency, security, and convenience of managing its accounts and financial transactions;

WHEREAS, there is a need to formally authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, to register and enroll all LGU accounts maintained at the Land Bank of the Philippines, Pagadian City Branch, in the said WeAccess system, including the designation of appropriate officials as authorizers and makers for such accounts;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. ARNOLD L. FLORES**, the body resolved, as it hereby resolves to authorize the Local Chief Executive, Honorable Mayor Junaflor S. Cerilles, RMT, MAGD to register and enroll all accounts of the Local Government Unit of Dumalinao maintained at the Land Bank of the Philippines, Pagadian City Branch to WE ACCESS SYSTEM, including the authorizers and makers thereof.
