RESOLUTION NO. 057-2022

HUMBLY REQUESTING THE PROVINCIAL GOVERNOR OF ZAMBOANGA DEL SUR, HONORABLE VICTOR J. YU, TO ALLOCATE FUNDS FOR THE PROPOSED ROAD OPENING PROJECT FROM BARANGAY CAMALIG TO BARANGAY BANTA-AO, DUMALINAO, ZAMBOANGA DEL SUR.

WHEREAS, presented for consideration and appropriate action is the proposed resolution of Hon. Hermes B. Cabales to request the Provincial Governor of Zamboanga del Sur, Honorable Victor J. Yu, to allocate funds for the proposed road opening project from Barangay Camalig to Barangay Banta-ao, Dumalinao, Zamboanga del Sur;

WHEREAS, Section 17 (b) (2) (viii) of the Local Government Code of 1991, states that the LGU shall provide services and facilities include, but are not limited to infrastructure facilities intended primarily to service the needs of the residents of the municipality and which are funded out of municipal funds including, but not limited to, municipal roads and bridges; school building and other facilities for elementary and secondary schools; clinics, health centers and other health facilities necessary to carry out health services; communal irrigation, small water impounding projects and other similar projects; fish ports; artesian wells, spring



development, rainwater collectors and water supply system; seawalls, dikes, drainage and sewerage, and flood control; traffic signals and road signs; and similar facilities, as part of the basic services devolved to the municipalities;

WHEREAS, the Municipality of Dumalinao is a 4th class municipality in the Province of Zamboanga del Sur, which is politically subdivided into 30 barangays with an estimated population of 32 013;

WHEREAS, road networks have a direct influence on basic production parameters, which in turn, will foster economic development, reduce absolute poverty by improving economic efficiency as it decreases costs and prices and enhances trade and employment opportunities and even of very basic social services;

WHEREAS, majority of its residents, most especially the farmers and the commuters, always dream of road concreting projects which will provide vast agricultural products, easy access to the market, and consequently it will also benefit not only the domestic tourism but more importantly the upland and lowland farmers;

WHEREAS, considering the limited resources of the LGU, this august body deemed it necessary to source out funds, hence to appeal to the good Governor, Honorable Victor J. Yu, for financial assistance;

WHEREAS, after careful review and exhaustive deliberation, and after finding the same to be proper and order;

NOW, THEREFORE, premises above-considered, on motion by **HON. FREDERICK R. BALANDRA** the body resolved, as it hereby resolves to request the Provincial Governor of Zamboanga del Sur, Honorable Victor J. Yu, to allocate funds for the proposed road opening project from Barangay Camalig to Barangay Banta-ao, Dumalinao, Zamboanga del Sur.
