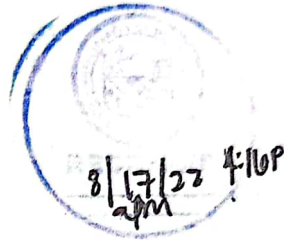


Madam:

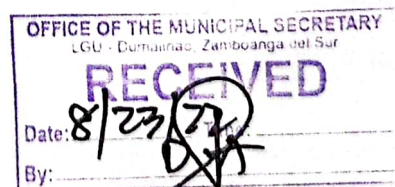

WHEREAS, the Locuban National High School has enough buildable space should there be additional building for educational purpose;






